BirdLife Australia's plan to stop the extinction crisis and put native birds on a path to recovery.

Birds enrich all life on the planet.

Birds are our connection to the natural world, which we all depend on for life.

By tracking the health of birds, we track the pulse of our natural environment.

Rapid change brought about by humans is reducing nature's capacity to sustain birds and life for the future.

In the face of nature's changes, threatened bird species need our help to survive.

We need to set ambitious goals, collaborate at scale, and work together with local communities to save birds.

Rigorous science combined with practical on the ground action is essential to save Australia's birds and habitats.

Together we can recover threatened birds, restore nature and stop extinctions.

Working with scientists, partners, and a strong community of people passionate about birds and their habitats, we combine the best of conservation practice and sound science to achieve critical wins for Australia's most threatened birds.

Our strong foundations in science and partnership, and membership of BirdLife International, the world's largest nature conservation partnership, equip us for the challenge of stopping extinctions and saving birds. And this challenge has never been greater.

75% of the world's land surface has been significantly altered and 85% of wetlands globally have been lost. Unsustainable agriculture, forestry and fisheries drive habitat destruction and degradation worldwide; climate change, pollution, and invasive species present massive challenges; and it is crystal clear that the crises of biodiversity loss, climate change and health are linked.

Birds are our 'early warning' system for threats to nature and to the ecology that supports our forests, farms, and fisheries. And there is no doubt that birds are more vulnerable than ever. They urgently need our help to survive.

Australia's extinction crisis should alarm us all. It must serve as a catalyst for an ambitious, comprehensive, and evidenced plan for change, and that's what BirdLife will deliver through this Bird Conservation Strategy.

This bold strategy is a rally cry for us all to step up and do more to recover bird species and restore fragile ecosystems for future generations. Join us as we rise to meet the challenge of creating and sustaining a healthy planet for the benefit of all.

#### **Our incredible bird life**

Australia is an avian wonderland, from the birds that are truly one of a kind, like the bizarre Plains-wanderer, to the array of colourful parrots and cockatoos that light up our skies, the soaring albatrosses and terns of our oceans and the tough little finches of our deserts.

Australia is home to 1,200 different birds, 45% of which are found nowhere else in the world.

Many of our birds perform vital roles within our ecosystems: they keep other animals, plants, and insects in balance, spread seeds and pollen to create new life, and maintain healthy habitats.

Birds respond quickly to changes in the environment and are early-warning messengers for the health of the planet. Their disappearance is an alarm bell signalling that something is wrong, and their presence a joyful clarion when things are in balance.

But birds are not just barometers of ecosystem health, they are also ambassadors for a healthier planet. Looking after birds means looking after everything in nature-and that includes us.

#### A fight for survival

We understand the enormity of the challenges we face in our mission to restore birds and their habitats. Rapid change is reducing nature's capacity to sustain every bird species and they urgently need our help to survive. Both in Australia and globally, we are living in an environmental and extinction crisis.

Unsustainable agriculture, forestry, and fisheries cause habitat destruction and degradation and, combined with climate change, pollution, and invasive species, put incredible pressure on our native birds, to the point that one in six Australian bird species is now threatened.

These changes are reducing nature's capacity to sustain birds and life for the future, they are also putting our own health and survival as a species on the line.

Research by the Intergovernmental Science Policy Panel on Biodiversity and Ecosystem Services shows that

#### 85% of wetlands have been lost.



66% of ocean area is experiencing increasing cumulative impacts.



680 vertebrate species have been driven to extinction.



1 million species are estimated to be threatened with extinction.



#### **BirdLife Australia**

BirdLife Australia is the national bird conservation charity that's fighting to save birds and the natural life systems on which they depend.

By 2032, to put birds and nature on a path to recovery by informing and leading action to halt biodiversity loss and restore ecosystems.

Stop human-driven extinction of threatened birds by 2032.

Improve the status of at least 30% of threatened birds by 2032.

Halt overall bird species population declines by 2050.

#### Focus

We drive change through four connected and evidence-led areas of focus

#### **Species**

We have achieved remarkable wins for some of Australia's most endangered birds, but we must do more to reverse the decline of our native species and put birds on a path to recovery.

As the national experts on bird conservation, we drive innovative, collaborative solutions that safeguard the long-term future of all Australian native birds.

#### Sites

We save birds by protecting where they live. Working with partners, we identify, conserve and restore a network of sites, including Key Biodiversity Areas (KBAs), that make a significant contribution to global biodiversity, and are connected and integrated into wider land and seascapes.

#### **Systems**

The systemic drivers perpetuating native bird and habitat decline can only be addressed through stronger legislation and policy, changed industry practices and an end to harmful subsidies.

Through evidence and advocacy, we influence policies, practices, incentives and decision-making processes that support bird and habitat conservation.

#### Society

We can't do this alone. By inspiring and equipping a constituency of people dedicated to safeguarding the future of birds, we amplify our message and act as the voice for Australia's birds.

We deliver sustainable change by collaborating with local communities, mobilising the Australian public, and both working with, and influencing, decision makers in public and private sectors.



#### Approach

#### Partner

To successfully achieve our ambitious strategy and drive transformational change we must multiply our impact by strengthening our existing partnerships, establishing new ones and collaborating with local communities to lead change. Partnerships are instrumental in our work to:

- 1. Ensure climate solutions are genuinely nature positive such as carbon market mechanisms and financing for habitat restoration.
- 2. Conduct research and obtain data needed to identify and recover birds at risk of extinction.
- 3. Deliver threatened species recovery actions including establishing insurance populations for the most threatened species, conserving critical habitat and increasing areas in the reserve network.
- 4. Influence policy and legislation including advocating for the removal of harmful government incentives for clearing critical habitat (such as subsidising the logging of Swift Parrot habitat), increasing resources available for the recovery of threatened species, and influencing the design and implementation of stronger nature laws.
- 5. Inform nature-positive business practices by influencing consumer demand and market choices and by promoting solutions that balance profitability and biodiversity outcomes.

#### Step Up

Complex global challenges demand intelligent global responses. The global BirdLife partnership is committed to a set of imperatives to address the systemic drivers of species and habitat loss.

- Climate advancing natural solutions
  to the climate and biodiversity crises
- Agriculture supporting agricultural reforms including nature-friendly farming
- Marine pioneering marine and coastal conservation and sustainable fisheries
- Connectivity championing flyways and transboundary conservation worldwide
- Mainstream integrating nature into government, corporate and financial decision-making
- Mobilise engaging local, youth and urban communities in nature conservation
- Health positively integrating biodiversity, environmental and human health

#### Scale up

We are increasing the scale of our Bird Conservation Programs and capacity to deliver our Conservation Action Plans, for example:

1. Influencing policy by championing stronger nature laws, especially to safeguard critical habitats; reversing the impacts of broadscale landclearing and unsustainable forestry and mining; advocating for better water management and promoting appropriate fire regimes.



- 2. Influencing business practices such as working with urban planners to integrate biodiversity into the design of our cities and promoting practices that protect birds on farms and restore woodland bird habitat.
- 3. Identifying and managing Key Biodiversity Areas including advocating internationally, particularly across the East Asian-Australasian Flyway, marine KBAs, and other areas of high integrity.
- 4. Leading threatened species recovery actions, implementing emergency interventions for birds on the brink and coordinating with experts to develop and mobilise resources for the implementation of strong recovery plans.



### **Nature-based Solutions**

BirdLife works with corporates, landowners and carbon project lead partners to co-design best practice restoration projects in priority landscapes for threatened species. These solutions deliver both carbon and biodiversity outcomes for declining bird species as well as benefits to local communities.



## **Birds on Farms**

Our Birds on Farms program supports landholders to restore bird populations and habitats on private rural properties. Through training workshops, site visits, tailored habitat plans and support accessing incentives, we work with landholders to create landscapes that are both agriculturally productive and profitable and which help to restore woodland bird habitats.
