

# Southwest Black-Cockatoo Recovery Coordinator Position Description

## The organisation

As Australia's only national bird conservation charity, we are on a mission to put birds and nature on the path to recovery within a decade, leading and facilitating action that halts biodiversity loss and restores ecosystems. ## Position title

Southwest Black-Cockatoo Recovery Coordinator

# Position objective

BirdLife Australia is a lead organisation for the recovery of threatened birds in Australia. This position will play a key role in recovery action coordination for the three Black-Cockatoos endemic to southwest Australia (*Calyptorhynchus banksii naso, Zanda baudinii*, and *Zanda latirostris*) as the new multi-species Recovery Plan for these taxa is developed. Working with the Recovery Team, state, local and federal governments, community organisations, natural resource management authorities, researchers and special interest groups and other representatives this position will support the development of this Recovery Plan and enable the implementation of key recovery actions and initiatives identified in the Plan.

## Status

This role is a part-time (0.8 FTE) role until March 2026, offered on a maximum term contract. Continuation will be subject to available funding.

## Remuneration / Job Level

Full time salary at Grade 3, with level-based program complexity, scale, experience and expertise.

## Location

The preferred position will be based in Perth, Western Australia. Alternative locations will be considered based on strategic merit.

# Duties

Work with the Manager Black-Cockatoos, Manager Policy and Species Recovery, and Species Recovery Support Coordinator to:

- Assist in the compilation of documentation, coordination of workshops or other activities, to inform the development of the new multispecies Southwest Black-Cockatoo Recovery Plan;
- Promote the development of the new plan through other workshops, on-ground actions and community outreach opportunities;
- Assist drafting clear terms of reference and other support tools for the new Recovery Plan.
- Assist with the organisation of Recovery Team meetings;
- Facilitate communication between Recovery Team members, conservations partners, and other external stakeholders;
- Support the implementation of and monitor performance against the multispecies Southwest Black-Cockatoo Recovery Plan and key conservation projects that are identified as priorities under this plan, aligned to BirdLife's mission and vision and indicators under the Bird Conservation Strategy;
- Support Recovery Plan coordination initiatives, including TSX data reporting, improved governance and coordination of key initiatives through the committee members, actions and strategies, annual reporting under the National Reporting Framework to Federal Government;
- Contribute to key evaluation, learning and improvement in governance, coordination and communications requirements for the Recovery Team and Recovery Plan;
- Support and lead initiatives to grow funding and resources to implement key conservation actions, including preparation of grant applications and funding pitches, and development of relationships with key funders, to develop the capacity, scale and reach of the program and local projects;
- Assist in preparation of written communications, media, web content, events and advice to groups to assist with delivery of recovery actions;
- Participate in the BirdLife Recovery Coordination community of practice;
- Assist the Recovery Team and BirdLife to identify potential legislative or policy opportunities to improve Black-cockatoo conservation and habitat management and protections and to identify any potential proposals that could impact their conservation, develop or contribute to submissions, and engage in consultations;
- Work as part of a team that ensures continuous organisational improvement and takes responsibility for creating a positive work environment; and
- Other duties as required by the Recovery Team's activities, goals and targets that are reasonable and within the scope of the current position description.

# Selection Criteria

# Essential

• University qualifications in ecology or another relevant discipline, and at least 5 years' experience working in the field of applied conservation.

- Strong knowledge of species recovery, management of threats and conservation solutions, technical expertise in species conservation.
- Strong interpersonal, representational and relationship-building skills, including experience managing and consulting with stakeholder groups, and conflict resolution skills.
- Experience working with multiple stakeholders, committees and community.
- Strong project management skills, including budget management and reporting.
- Ability to self-start, work to tight timelines and demonstrated experience delivering grants on time, on budget and to the funder's satisfaction.
- Demonstrated ability to work both independently and as part of a team.
- Excellent written, verbal and interpersonal communication skills. Competency in word processing.

# Desirable

- A post-graduate degree in ecology or another relevant discipline.
- An understanding of Black-Cockatoo ecology and conservation, and the challenges they face.
- Demonstrated analytical skills, including managing and analysing datasets, and knowledge of other tools, including MERIT.
- Demonstrated interest in and knowledge of threatened species conservation and recovery programs.
- An appreciation and understanding of science-based conservation, and a desire to find practical solutions to managing human-wildlife conflict.
