1. Welcome

BirdLife Australia President Mandy Bamford (MB) opened the meeting and welcomed members, supporters, and staff attending in person and those joining via the livestream webinar. There being a quorum, the meeting was declared open at 9.37am.

MB acknowledged the Traditional Owners of the land. She thanked the board directors for their efforts throughout 2024, especially Gerard Early, who stepped down from the board after joining in 2011. MB said that GE has been a voice of extraordinary support, wisdom and reason to the board, and his contributions to BirdLife have been hugely valued.

3. President's Address

MB reflected that the strength of BirdLife Australia lies in its people, and the past year has shown just how powerful that collective force can be in achieving real wins for birds and their habitats. BirdLife has strengthened its partnerships across science, community and policy and our expertise is increasingly being recognised by governments, communities and fellow conservation organisations. BirdLife's work is changing the future of Australia's birds.

MB thanked the Board, CEO, executive team, staff, volunteers, members and donors for their generosity and support for BirdLife Australia.

4. Minutes of the 2024 Annual General Meeting held on 25 May 2024

The minutes of the 2024 Annual General Meeting held on 25 May 2024 were published on the BirdLife Australia website and available to members on request. The count of proxy votes was in favour of accepting the minutes of the 2024 Annual General Meeting. The President called for the minutes of the 2024 AGM to be adopted. The minutes of the BirdLife Australia Annual General Meeting held on 27 May 2024 were adopted as a true and correct record of that meeting.

5. Annual Report of Directors for the Year Ended 31 December 2024

The President thanked the Board Directors and acknowledged the significant amount of time given by our volunteers to support BirdLife. In addition, MB commended members who made time this year to get to know KM and the other new staff members around the country, which helps our ability to work as one organisation and get better outcomes for birds.

MB introduced and presented each of the Board directors in attendance to the members.

The count of proxy votes was in favour of accepting the Annual Report of Directors.

6. Presentation of the Financial Accounts of the Company and the Auditors' Report for the Year Ended 31 December 2024

Gary Nelson (GN), Chair of the Finance & Audit Committee, presented the Financial Accounts and the Auditors' Report for 2024 on behalf of the Board. He confirmed that an independent auditor RSM was engaged to ensure that BirdLife's financial statements were fairly and appropriately presented, and compliant with the not-for-profit requirements of the Australian Accounting Standards Board (AASB). The organisational structure of BirdLife was established following the recent reforms to align with the strategic plan. The organisation is now structured around four key functional areas: conservation and science, participation and engagement, strategy and governance, finance and business improvement. The structure recognises the branches, the observatories and special interest groups, as they are an integral part of the national network.

In 2024 revenue was just under \$15M. BirdLife had a strong result for bequests, totalling just under \$1.8M, and an uplift in the value of our investments. These uplifts have enabled us to support strategy. Donations and bequests are becoming a more important income source complementing the income received from grants.

Total expenditure has increased slightly, mostly attributable to the strategic investment in our systems, staffing and governance, together with a number of one-off costs associated with the organisational restructure. 2024 had an operating deficit of \$3.1M, which was a planned deficit reflecting the strategic decision to invest in systems. This deficit is anticipated to reduce significantly in the next two years.

BirdLife remains in a strong financial position, with good governance and a pathway to break even in 2026. The full financial report, income expenditure reserves and financial strategy are available in the Annual Report.

There were no questions from the members throughout the presentation.

The President called for the Financial Accounts and the Auditors' Report for the year ending 31 December 2024 to be adopted.

The count of proxy votes were also in favour for accepting the accounts.

7. Declaration of the Election of Directors

All eligible voting members were notified and invited to submit nominations to the Board through the member magazine, *Australian Birdlife*, and on the BirdLife Australia website. A summary candidate statement and ballot forms were posted to members in their AGM notification pack. The full candidate statement was also available on the BirdLife AGM website.

According to the Constitution, the voting for Board Directors must commence after 10:00am (AEST) after the in-person ballot count has ended. Following a count of proxy and attendee votes, Gerard Early (GE) announced that Mandy Bamford was elected for a further three years. 299 people were in favour of MB's election.

GE congratulated MB on being elected.

8. Presentation of BirdLife's Achievements in 2024

BirdLife Australia's Chief Executive Officer, Kate Millar (KM), gave a presentation on the organisation's achievements in 2024. Her presentation covered key activities in 2024, including:

- BirdLife has had almost 900,000 visitors to the website, 216,00 surveys logged in Birdata and almost 60,000 people completed the Aussie Bird Count.
- Using 50 years of data collection, BirdLife successfully halted the construction of a windfarm at Westernport Bay, protecting migratory shorebirds.
- The biennial Hooded Plover count was extended to Tasmania. At Lorne, the first pair produced chicks since the 80s, generating local excitement.
- Bio-acoustic monitoring of the Mukarrthippi Grasswren has begun.
- Saved the Cocanarup Reserve, saving black-cockatoos.
- After ten years of effort, Toondah Harbour was saved. KM particularly noted Judith Hoyle's contributions to this achievement.
- Birds on Farms continues its crucial work.
- Beach nesting birds conference was very well attended, with a key attendance by First Nations People. This conference translates science into meaningful outcomes around the country.
- The Red Goshawk National Monitoring Program is engaging Traditional Owners across the Cape York Peninsula, Tiwi Islands and Arnhem Land, supported by a tailored monitoring training program.
- KM spoke at the Senate Inquiry in Canberra into environmental reforms, articulating the importance of a 'Nature Positive' approach and the role Environment Information Australia should play.
- The organisational restructure was a challenging process for KM and for staff, and KM wishes to acknowledge the contribution of the staff who have moved on and hopes they will remain part of the flock. KM also noted the strength of the new staff and the expertise they bring. She hopes to create one flock with one purpose.
- The Aussie Bird Count recorded 4 million birds and drew wide media coverage.

KM encouraged all members to read the Annual Report for further information on BirdLife's impact and achievements.

Nominations are made by members of BirdLife Australia and are considered and recommended by the Scientific Awards Committee and the Research & Conservation Committee before being approved by the Board. This award is made by the Board and does not require confirmation by members. The full citations of all award recipients are available on our website.

The President announced that Ann Lindsey was awarded the JN Hobbs Memorial Medal. A short video prepared by Ann was played to the attendees.

The President congratulated Ann for her very well-deserved recognition.

No Fellow nominations or the DL Serventy Award were received for 2024 and MB suggested that people consider nominations for next year, all details available on the website.

11. Questions and Other Matters from Members Submitted by Proxy
